SUMMARY: (U) NUMEROUS UFO SIGHTINGS HAVE BEEN MADE IN BELGIUM SINCE NOV 89. THE CREDIBILITY OF SOME INDIVIDUALS MAKING THE REPORTS IS GOOD. SOME SIGHTINGS HAVE BEEN EXPLAINED BY NATURAL/MANMADE PHENOMENA, SOME HAVE NOT. INVESTIGATION BY THE BAF CONTINUES.

TEXT: 1. (U) NUMEROUS AND VARIOUS ACCOUNTS OF UFO SIGHTINGS HAVE SURFACED IN BELGIUM OVER THE PAST FEW MONTHS. THE CREDIBILITY OF THE OBSERVERS OF THE ALLEDGED EVENTS VARIES FROM THOSE WHO ARE UNSOPHISTICATED TO THOSE WHO ARE THE WELL EDUCATED AND PROMINENTLY PLACED.

2. (U) SOURCE A CITES MR LEON BRENIG, A 43 YEAR OLD PROFESSOR AT THE FREE UNIVERSIY OF BRUSSELS (PROMINENT) IN THE FIELD OF STATISTICS AND PHYSICS. HE CLAIMS TO HAVE TAKEN PICTURES OF THE PHENOMENA WHICH ARE STILL BEING DEVELOPED BUT WILL BE PUBLISHED BY THE BELGIAN SOCIETY FOR THE STUDY OF SPACE PHENOMENA IF THEY ARE OF GOOD QUALITY.

3. (U) MR BRENIG WAS DRIVING ON THE ARDENNES AUTOROUTE IN THE BEAUFAYS REGION EAST OF LIEGE, SUNDAY, 18 MARCH 1990. AT 2030 HOURS WHEN HE OBSERVED AN AIRBORNE OBJECT APPROACHING IN HIS DIRECTION FROM THE NORTH. IT WAS IN THE FORM OF A TRIANGLE ABOUT THE SIZE OF A PING-PONG BALL AND HAD A YELLOW LIGHT SURROUNDING IT WITH A REDDISH CENTER VARYING IN INTENSITY. ALTITUDE APPEARED TO BE 500 - 1000 METERS, MOVING AT A SLOW SPEED WITH NO SOUND. IT DID NOT MOVE OR BEHAVE LIKE AN AIRCRAFT.

4. (U) MR BRENIG CONTACTED A FRIEND VERY NEAR THE AREA WHO CAME OUT AND TOOK PICTURES OF IT WITH A ZOOM LENS AND 400 ASA FILM. BOTH INSISTED THE OBJECT COULD NOT BE AN AIRCRAFT OR HOLOGRAMME PROJECTION AS THE SKY WAS CLCUDLESS.

5. (U) THE SOURCE B ARTICLE WHICH DISCUSSES A BELGIAN TELEVISION INTERVIEW WITH COL WIL ((DEBROUWER)), CHIEF OF OPERATIONS FOR THE BAF, MOST LIKELY WAS THE RESULT OF A FOLLOW-ON ACTION TAKEN BY MR BRENIG WHEN HE CONTACTED LTGEN ((TERRASSON)), COMMANDER, BELGIAN TACTICAL (OPERATIONAL) COMMAND. GEN TERRASSON CATEGORICALLY ELIMINATED ANY POSSIBLE BAF AIRCRAFT OR ENGINE TEST INVOLVEMENT WHICH COL DEBROUWER CONFIRMED DURING THE 25

6. (U) DEBROUWER NOTED THE LARGE NUMBER OF REPORTED SIGHTINGS, PARTICULARLY IN NOV 89 IN THE LIEGE AREA AND THAT THE BAF AND MOD ARE TAKING THE ISSUE SERIOUSLY. BAF EXPERTS HAVE NOT BEEN ABLE TO EXPLAIN THE PHENOMENA EITHER.

7. (U) DEBROUWER SPECIFICALLY ADDRESSED THE POSSIBILITY OF THE OBJECTS BEING USAF B-2 OR F-117 STEALTH AIRCRAFT WHICH WOULD NOT APPEAR ON BELGIAN RADAR, BUT MIGHT BE SIGHTED VISUALLY IF THEY WERE OPERATING AT LOW ALTITUDE IN THE ARDENNES AREA. HE MADE IT QUITE CLEAR THAT NO USAF OVERFLIGHT REQUESTS HAD EVER BEEN RECEIVED FOR THIS TYPE MISSION AND THAT THE ALLEGED OBSERVATIONS DID NOT CORRESPOND IN ANY WAY TO THE OBSERVABLE CHARACTERISTICS OF EITHER U.S. AIRCRAFT.

8. (U) MR BRENIQ HAS SINCE ASSURED THE COMMUNITY THAT HE IS PERSONALLY ORGANIZING A NEW UFO OBSERVATION CAMPAIGN AND SPECIFICALLY REQUESTS THE HELP OF THE BELGIAN MOD.

9. [REDACTED] RELATED A SIMILAR UFO SIGHTING WHICH APPARENTLY HAPPENED TO A BELGIAN AIR FORCE OFFICER IN THE SAME AREA NEAR LIEGE DURING NOVEMBER 89. THE OFFICER AND HIS WIFE WERE ALLEGEDLY BLINDED BY A HUGE BRIGHT FLYING OBJECT AS THEY WERE DRIVING ON THE AUTOROUTE. THEY STOPPED THEIR CAR, BUT WERE SO FRIGHTENED THEY ABANDONED THE VEHICLE AND RAN INTO THE WOODS. THEY COULD NOT PROVIDE A DETAILED DESCRIPTION BUT WHATEVER IT WAS DEFINITELY APPEARED REAL TO THEM. [REDACTED] UNDERLINED THEIR CREDIBILITY AS SOLID.

COMMENTS: 1. [REDACTED] COMMENT. HE COULD PROVIDE VERY LITTLE CONCRETE INFORMATION EXCEPT TO VERIFY THE LARGE VOLUME OF SIGHTINGS AND THE SIMILARITY OF SOME DURING NOV 89. [REDACTED]

2. [REDACTED] THE BAF HAS RULED SOME SIGHTINGS WERE CAUSED BY INVERSION LAYERS, LASER BEAMS AND OTHER FORMS OF HIGH INTENSITY LIGHTING HITTING CLOUDS. BUT A REMARKABLE NUMBER OCCURRED ON CLEAR NIGHTS WITH NO OTHER EXPLAINABLE ACTIVITY NEARBY.

3. [REDACTED] THE BAF IS CONCERNED TO A POINT ABOUT THE UFO ISSUE AND IS TAKING ACTION TO INVESTIGATE INFORMATION THEY HAVE. [REDACTED] DOES ADMIT, HOWEVER, THAT HE IS NOT OPTIMISTIC ABOUT RESOLVING THE PROBLEM.

4. [REDACTED] FIELD COMMENT. THE USAF DID CONFIRM TO THE BAF AND BELGIAN MOD THAT NO USAF STEALTH AIRCRAFT WERE OPERATING IN THE ARDENNES AREA DURING THE PERIODS IN

QUESTION. THIS WAS RELEASED TO THE BELGIAN PRESS AND RECEIVED WIDE DISSEMINATION.

8A. DETAILS: SOURCE TOLD RD ABOUT THE SPOTTING OF AN UNIDENTIFIED FLYING OBJECT IN THE VICINITY OF MARIANO MELGAR AIR BASE, LA JOYA, PERU (18885N, 871538W). SOURCE STATED THAT THE VEHICLE WAS SPOTTED ON TWO DIFFERENT OCCASIONS, THE FIRST WAS DURING THE MORNING HOURS OF 9 MAY 88, AND THE SECOND DURING THE EARLY EVENING HOURS OF 10 MAY 88.

SOURCE STATED THAT ON 9 MAY, WHILE A GROUP OF FAP OFFICERS WERE IN FORMATION AT MARIANO MELGAR, THEY SPOTTED A UFO THAT WAS ROUND IN SHAPE, HOVERING NEAR THE AIRFIELD. THE AIR COMMANDER SCRAMBLED AN SU-22 AIRCRAFT TO MAKE AN INTERCEPT. THE PILOT, ACCORDING TO A THIRD PARTY, INTERCEPTED THE VEHICLE AND FIRED UPON IT AT VERY CLOSE RANGE WITHOUT CAUSING ANY APPARENT DAMAGE. THE PILOT TRIED TO MAKE A SECOND PASS ON THE VEHICLE, BUT THE UFO OUT-RAN THE SU-22.

THE SECOND SIGHTING WAS DURING HOURS OF DARKNESS. THE VEHICLE WAS LIGHTED, AGAIN AN SU-22 WAS SCRAMBLED, BUT THE VEHICLE OUT-RAN THE AIRCRAFT.

8B. ORIG CTR: RD HAS HEARD DISCUSSION ABOUT THE SIGHTING FROM OTHER SOURCES, APPARENTLY SOME VEHICLE WAS SPOTTED, BUT ITS ORIGIN REMAINS UNKNOWN.

THAT THEY HAD SEEN STRANGE OBJECTS IN THE SKY. SOME REPORTED A KIND OF BIRD-LIKE OBJECT WHILE OTHERS REPORTED A HELICOPTER WITH A LIGHT ON. THERE WERE NO HELICOPTERS AIRBORNE AT THAT TIME.

AFTER HE TOLD THE CITIZEN IT WAS ONLY STARS AND HAD TALKED TO MEHRABAD TOWER HE DECIDED TO LOOK FOR HIMSELF. HE NOTICED AN OBJECT IN THE SKY SIMILAR TO A STAR BIGGER AND BRIGHTER. HE DECIDED TO SCRAMBLE AN F-4 FROM SHAHROKH AFB TO INVESTIGATE.

A. AT 0130 HRS ON THE 19TH THE F-4 TOOK OFF AND PROCEEDED TO A POINT ABOUT 40 NM NORTH OF TEHRAN. DUE TO ITS BRILLIANCE THE OBJECT WAS EASILY VISIBLE FROM 70 MILES AWAY. AS THE F-4 APPROACHED A RANGE OF 25 NM HE LOST ALL INSTRUMENTATION AND COMMUNICATIONS (UHF AND INTERCOM). HE BROKE OFF THE INTERCEPT AND HEADED BACK TO SHAHROKHI. WHEN THE F-4 TURNED AWAY FROM THE OBJECT AND APPARENTLY WAS NO LONGER A THREAT TO IT THE AIRCRAFT REGAINED ALL INSTRUMENTATION AND COMMUNICATIONS. AT 0140 HRS A SECOND F-4 WAS LAUNCHED. THE BACKSEATER ACQUIRED A RADAR LOCK ON AT 27 NM. 12 O'CLOCK HIGH POSITION WITH THE VC (RATE OF CLOSURE) AT 150 KMPH. AS THE RANGE DECREASED TO 25 NM THE OBJECT MOVED AWAY AT A SPEED THAT WAS VISIBLE ON THE RADAR SCOPE AND STAYED AT 25NM.

C. THE SIZE OF THE RADAR RETURN WAS COMPARABLE TO THAT OF A 707 TANKER. THE VISUAL SIZE OF THE OBJECT WAS DIFFICULT TO DISCERN BECAUSE OF ITS INTENSE BRILLIANCE. THE LIGHT THAT IT GAVE OFF WAS THAT OF FLASHING STROBE LIGHTS ARRANGED IN A RECTANGULAR PATTERN AND ALTERNATING BLUE, GREEN, RED AND ORANGE IN COLOR. THE SEQUENCE OF THE LIGHTS WAS SO FAST THAT ALL THE COLORS COULD BE SEEN AT ONCE. THE OBJECT AND THE PURSUING F-4 CONTINUED ON A COURSE TO THE SOUTH OF TEHRAN WHEN ANOTHER BRIGHTLY LIGHTED OBJECT, ESTIMATED TO BE ONE HALF TO ONE THIRD THE APPARENT SIZE OF THE MOON, CAME OUT OF THE ORIGINAL OBJECT. THIS SECOND OBJECT HEADED STRAIGHT TOWARD THE F-4 AT A VERY FAST RATE OF SPEED. THE PILOT ATTEMPTED TO FIRE AN AIM-9 MISSILE AT THE OBJECT BUT AT THAT INSTANT HIS WEAPONS CONTROL PANEL WENT OFF AND HE LOST ALL COMMUNICATIONS (UHF AND INTERPHONE). AT THIS POINT THE PILOT INITIATED A TURN AND NEGATIVE G DIVE TO GET AWAY. AS HE TURNED THE OBJECT FELL IN TRAIL AT WHAT APPEARED TO BE ABOUT 3-4 NM. AS HE CONTINUED IN HIS TURN AWAY FROM THE PRIMARY OBJECT THE SECOND OBJECT WENT TO THE INSIDE OF HIS TURN THEN RETURNED TO THE PRIMARY OBJECT FOR A PERFECT REJOIN.

D. SHORTLY AFTER THE SECOND OBJECT JOINED UP WITH THE PRIMARY OBJECT ANOTHER OBJECT APPEARED TO COME OUT OF THE

OTHER SIDE OF THE PRIMARY OBJECT GOING STRAIGHT DOWN AT A :  
CERTAIN RATE OF SPEED. THE F-4 CREW HAD REGAINED COMMUNICATIONS  
AND THE WEAPONS CONTROL PANEL AND WATCHED THE OBJECT APPROACH  
THE GROUND ANTICIPATING A LARGE EXPLOSION. THIS OBJECT APPEARED  
TO COME TO REST GENTLY ON THE EARTH AND CAST A VERY BRIGHT  
LIGHT OVER AN AREA OF ABOUT 2-3 KILOMETERS.

## INTRODUCTION

CSETI is a non-profit tax-exempt research and educational organization incorporated in the state of North Carolina with members worldwide. Its primary goals are to:

- A. Establish a real-time diplomatic and research initiative to contact extraterrestrial civilizations, leading to a sustainable, peaceful and mutually beneficial relationship, and
- B. Educate all sectors of human society about this subject in a credible and non-harmful manner.

The CSETI project currently has 25 Working Groups worldwide which are conducting research and is guided by a 10-member Executive Council and an International Director, Steven M. Greer, M.D. A senior diplomatic and research team known as the Rapid Mobilization Investigative Team (RMIT) responds to areas of significant apparent extraterrestrial activity and has successfully established contact with extraterrestrial spacecraft in the United States, Mexico, England, and Belgium (see CSETI research results case summaries, section III and Appendix II).

CSETI is funded through charitable donations and memberships and has an all-volunteer staff. For further information about CSETI, see Appendix II.

The CSETI project will most likely advance in three phases:

**Phase I:** Establishing of research teams and RMIT with resulting low-level to moderate contact events, initiating early public education efforts on this subject; development of basic organizational structure and infrastructure. Phase I has been completed.

**Phase II:** Collecting the best available evidence on this subject with subsequent high-level briefings to leaders in society, world governments and international leadership; continuing RMIT and Working Group development with increasingly significant extraterrestrial contact, further organizational development with the securing of adequate funding commensurate with the scope and significance of the CSETI project, conducting a public announcement on this subject after leadership briefings are completed, with subsequent worldwide public education via major media. Phase II is in progress and advancing rapidly.

**Phase III:** Following the heightening of world awareness on this subject, we anticipate a significant augmentation in more direct and formal contact between CSETI teams and extraterrestrial civilizations. Indeed, the successful completion of Phase II in a controlled and non-harmful fashion is essential to more open and formal contact between humans and extraterrestrial peoples. It is anticipated that a full landing and boarding sequence will occur in this phase within the next 2-5 years.

## CSETI COMPREHENSIVE ASSESSMENT SUMMARY

- Recent worldwide trends of increasing extraterrestrial activity, coupled with significant advancement in CSETI research results, suggest that imminent extraterrestrial events and CSETI initiatives will soon overtake current government policy on this issue. It is recommended that governments worldwide review and change existing policy to one of increasing openness, disclosure and cooperation with civilian research teams. (See section IV on Strategies and Rationale for Changing Government Policy).
- Some UFOs are extraterrestrial spacecraft (ETS) which are piloted by extraterrestrial biological entities (EBEs) who originate on another planet, and most likely another star system.
- More than one extraterrestrial civilization is represented in the current activities involving earth.
- These extraterrestrial civilizations are working in concert and not competitively, although there is some specialization in function and activities for the various groups. This indicates that there exists either an emerging or well-established organization for these groups.
- These beings have bases within this solar system and may maintain temporary bases on earth, particularly under water.
- The variety in sizes and shapes of ETS observed is due to:
  - \* varying civilizations of origin, and more importantly,
  - \* *specialization of function, which include general reconnaissance, medical research and intelligence, earth environmental research, central command and base operations, energy generation and transfer, and human technology, military and space program research and reconnaissance.*
- Sudden and fully open contact with human civilization has been avoided because of a number of interrelated factors, including:
  - \* the need to avoid an untimely disruption of earth civilization including military, political, geopolitical, cultural, economic, technological and religious upheaval;
  - \* *risks to their own civilization and "people" as well as overall mission, given human xenophobia and tendencies towards violent armed reactions; and*
  - \* Up to this time, such massive and open contact has not been necessary, and has not been consonant with their overall long-term mission and purpose.
- A Plan is in place to allow for gradually broader and deeper contact with human society and individuals so that humans may become accustomed to the reality of other intelligent beings in the universe, and so that needed research and observation may take place on both sides. Limited but

increasing opportunities for bilateral and human initiated contact will occur in the reasonably near future.

- Sudden and large scale contact will occur only in the event of a significant worldwide emergency (manmade or natural).
- While ET observation and interaction with earth is probably an ancient as opposed to purely modern phenomenon, the marked increase in activity coinciding with World War II and the dawning of the "nuclear age" indicates that ETI are quite concerned about this transitional stage of human social evolution.
- Extraterrestrial intelligence (ETI) technology is strictly guarded by both ETI and human governmental agencies because of its potential for military applications which would greatly threaten world security. It is imperative that this technology not find significant human applications until such time as the earth is ready for it
- The US government, at least at the level of a highly compartmentalized top secret group, has known about the reality of these ETS and their occupants since at least 1947. A strict secrecy has been maintained due to:
  - \* Fear of public panic and social disruption;
  - \* Security issues surrounding possible military and technology application of ETI technology, especially in the setting of a world beset with Cold War tensions and competing interests;
  - \* Uncertainty and mistrust regarding ETI motives and intentions;
  - \* Embarrassment and consternation over human military inability to secure world air space from repeated penetrations by ETS.
- The U.S. government possesses several ETSs and the deceased bodies of several EBEs.
- The nature of "reality" of these craft and these beings has been incorrectly characterized by some as belonging to "another dimension and reality" from this dimension. Unfortunately, these statements are made without fully considering what "this reality" is. A more correct understanding of this is that the Full Spectrum of Reality is a singular, integrated one which may be perceived wholly or in its various aspects, such perception being entirely dependent on the level of consciousness of the perceiver. The various aspects of "dimensions" of this reality, which are limitless in number, are not restricted to or by time and space as we know it commonly. These beings and their craft belong to the same Reality as humans, however, their advancement in the realms of physical science and the science of consciousness has given them competence in a broader aspect of the Full Spectrum of Reality than is usually experienced by humans. The difference, then, is one of degree and not fundamental reality, since humans potentially have access to all aspects of the Full Spectrum of Reality just as extraterrestrial beings do. These differences are not insurmountable, nor are they truly fundamental; in fact they are relative and only temporary. While these beings are utilizing and experiencing a broader aspect of the Full

Spectrum of Reality, so too can and will humans, for we are as "inter-dimensional" by nature as they.

- ETS energy and "propulsion" systems utilize principles and laws of the physical universe not yet fully appreciated by human science, and may include:

- \* Gravity/anti-gravity and electromagnetic/gravity technology;
- \* Space energy and so-called hyperdimensional energy systems;
- \* Matter-energy interchangeable technologies; and
- \* Possible Consciousness Assisted Technology (CAT) and Technology Assisted Consciousness (TAC).

- Some, if not all, EBEs have advanced mental capabilities which include telepathy, precognition, remote viewing and others, indicating that they have developed the "science of consciousness" to a degree which parallels or surpasses their advanced physical technologies. Humans also possess these capabilities, but these remain largely undeveloped by most humans.

- EBEs are more developed or advanced than humans in a number of respects, but are not superior to humans as beings. Our point of unity and equality with EBEs is in our mutual existence as conscious intelligent beings. While these various EBEs may have values and priorities which are different from those of some 20th century humans, their motives and ultimate intentions are non-hostile and do not include the acquisition or subjugation of the earth and its peoples.

- The establishing of a lasting world peace and a just and effective world government is essential to the long-term ETI-Human relationship.

## The Foundation of Interplanetary Unity

The evidence that earth is being visited by at least one extraterrestrial civilization is extensive both in scope and detail. In its totality, it comprises a body of evidence which at the very least supports the general assessment that extraterrestrial life has been detected, and that a vigorous program of research and serious diplomatic initiatives is warranted.

Consider the following overview of facts:

- ◆ There are numerous daytime and nighttime photographs and videotapes of clearly non-human spacecraft from all over the world; these films and videotapes have been evaluated and deemed authentic by competent experts in optical physics and related fields.
- ◆ There are over 3500 military and commercial aircraft pilot reports of encounters worldwide; many cases have corroborating radar documentation and multiple witnesses both on the ground and in the air.
- ◆ There are over 4000 landing trace cases from around the world.
- ◆ There are hundreds of electromagnetic cases where spacecraft have been observed by police, military personnel and civilians to affect car engines, radios and other electric devices.
- ◆ There are over 100 first- and second-hand witnesses to the retrieval of an extraterrestrial spacecraft and at least four extraterrestrial bodies from a crash which occurred in July, 1947, 75 miles northwest of Roswell New Mexico; written and videotaped testimony from several first-hand witnesses who are respected military officers have been obtained.
- ◆ There are hundreds of credible reports, many with multiple witnesses, of humanoids in association with landed spacecraft.
- ◆ There are several multiple-witnessed events where humans have been taken on board spacecraft.
- ◆ CSETI (The Center for the Study of Extraterrestrial Intelligence) has in the past 18 months succeeded in intentionally establishing contact with extraterrestrial spacecraft, on two occasions at very close range, and with multiple witnesses present.
- ◆ Various polls have indicated that approximately 10% of Americans (25 million people) have seen them at close range so that details of the structure of the object can be discerned.
- ◆ Numerous U.S. Government documents exist which indicate that these objects are real and have been involved with observing earth for several decades.

It is an understatement to say that the time has arrived for a serious and open international dialogue regarding the possibility of future interplanetary relations. In no other area of human experience has so much evidence existed for so long, and yet been attended by such a paucity of serious research and analysis - at least in the civilian domain. I was once asked at a conference what was the most astounding aspect of this subject, and I replied that, while the subject matter itself is extraordinary, it is the absence of a serious human response to it that is most extraordinary.

Indeed, the true barriers to the furtherance of this field of study are neither scientific nor evidential, rather they are political, psychological, social, spiritual, and "paradigmatic". Admittedly, it takes real courage for a person, otherwise respected in his or her profession and community, to stand up and speak the truth about a subject which has been the stuff of sensational tabloid claims, crackpots, and the "cottage industry" in the UFO subculture. The social stigma and a probrium associated with this subject is a formidable barrier to the serious treatment it deserves, and yet if only a 10% probability exists that we have detected extraterrestrial life which is already visiting earth--this being one of the most profound discoveries in human history--we must find the inner fortitude to go forward.

To the sincere person who remains skeptical, consider this: Absolute proof is not needed before serious research begins on a subject. In no other field of human endeavor is proof required *before* serious study and research begins; on the contrary, proof is the result of this research. In this regard, the subject of extraterrestrial studies is being held to an irrational requirement of proof before serious research can begin, on the one hand, and denounced as an area of spurious interest because no proof exists, on the other!

This, then, is not a function of scientific reason or evidence, but is the result of a political, social and psychological reaction to a subject which causes most serious scientists to blush. Our collective temerity is driven in part by fear of the unknown, in part by fear of ridicule, and in part by faint-heartedness. The evidence, however, is so profound, the implications so vast, and the consequences of doing nothing so dire that we have reached the point where we must find the fortitude to respond to this subject in a mature and responsible way.

To any impartial observer, the evidence which exists certainly supports a greater than 10% probability that we are being visited by advanced extraterrestrial civilizations. Indeed, to most people who have seen the data in its entirety, the probability is in excess of 90%. Having spoken to several government officials who have held Top Secret clearances on this subject, and who have confirmed to me that the U.S. Government has in its possession several objects and bodies of extraterrestrial origin, my own personal assessment approaches certainty. Beyond this, I have personally been present when these spacecraft have approached the CSETI research teams within a few hundred feet, and have then signaled repeatedly to us. Frankly, there is very little doubt in my mind that we are dealing with at least one extraterrestrial civilization, and that they are non-hostile.

However, for argument sake, let us state that all of the evidence available to us in the civilian domain constitutes only a 10% probability of contact with extraterrestrial intelligence. Does this not constitute adequate evidence to initiate a serious scientific and diplomatic mission? Certainly in medicine a 10% probability of finding a cure for cancer would warrant an all out effort in the cancer research community. For it is generally true that when the stakes are very high, the probability of success need not be, prior to initiating a research project. Without question, the stakes are so high in this area that even a 10% probability is adequate to mount one of the most extensive worldwide research initiatives in history.

This question, however, is not limited to the realm of science alone, for as soon as one makes the assessment, however tentative, that we are being visited by advanced extraterrestrial life forms, the larger question of interplanetary (and inter-species) relations becomes preeminent. This is, then, the ultimate diplomatic challenge. And to find our common ground with intelligent life forms which are not even human may prove to be the most extraordinary task humanity has ever faced.

For witness how difficult it has been for humanity to come together in peace among the diverse peoples of the world. Notwithstanding the fact that we are all human, living on the one homeland called earth, yet wars, prejudices and enmity have repeatedly submerged the world into chaos and destruction. As the world moves, in fits and starts, towards a true world civilization, and the people of the world increasingly realize their essential unity as humans, the potential for increasingly open contact between humans and other intelligent life-forms is likely to increase exponentially.

However, before we can entertain this concept, we must first ask ourselves some basic questions:

- What global developments must occur before full open contact can take place?
- How will communication occur, and what should be communicated?
- Prior to full, open contact, what form of contact and communication is possible, in a pioneering or preliminary framework?
- And most importantly, what are the fundamental points of unity between humans and other intelligent life forms in the universe? What is our universal common ground?

Regarding this last question, we cannot assume that extraterrestrial life forms who are thinking, sentient beings, and who by definition have evolved under conditions different from those on earth, are likely to be much like humans, at least superficially. Their level of intelligence, fund of knowledge, emotional nature, social and political structures, ethical, moral and religious systems--and more--are likely to be quite different from that of humans. We must therefore find a deeper point of unity, what I call our highest common denominator.

This consideration, however abstract it may seem to some, is really central to establishing a sense of common ground between intelligent species. And without common ground, we can have no relationship.

I hold that this common ground is so obvious, and yet hidden, so near, and yet so overlooked, that it is easily missed altogether. It is at once simple and profound, proximal and yet hard to grasp. It is really the universal constant found in every intelligent life form: It is *conscious intelligence*.

Pure "awakeness" or conscious intelligence is what every conscious, sentient being in the universe is, in its essential nature. The universal - or non-anthropocentric - aspect of human consciousness is that highest common denominator on which a sustainable relationship between diverse life forms can be based. As humans, we are conscious, awake; other higher life forms are conscious and awake. We may share very little else in common, but this universal constant is shared, by definition, by all intelligent, conscious beings, whether human or extraterrestrial.

Consciousness, or universal conscious intelligence, then is the first cornerstone of the foundation of interplanetary unity.

Having realized the essential oneness which all intelligent higher life forms share, we are then faced with the practical challenge of formulating an approach to interplanetary and inter-species relations which is peaceful, sustainable and mutually beneficial. Here are a few of the principles which appear to be essential to the successful, sustained engagement of extraterrestrial civilizations:

- Any successful approach will incorporate a global perspective, and not one driven by nationalistic or strictly national security imperatives. The motive behind any attempt at contact and communication should clearly be globally based, and any benefits resulting from contact must benefit all the peoples of the world, and not just one nation or culture. The evolution of the world into a true global civilization will certainly facilitate this type of relationship. This entire matter, then, should be the focus of the international community. One of the hallmarks of the maturation of the human race is the attainment of a true world civilization and the establishing of a just and representative world government, which should be empowered to respond to the challenge of interplanetary relations. Until such a body is effectively functioning, any group attempting such contact should be operating within this global perspective.
- The motivation of such contact and relations should be based in the principle of mutual benefit, and be free of exploitative motives and unilateral acquisition-oriented goals. Until a permanent world peace and order can be achieved on earth, the acquisition of extraterrestrial technology, which most likely would be used for unilateral military application, should be avoided.
- While the precise motives for current extraterrestrial involvement with this planet may not be fully known, there is no evidence that they are motivated by any net hostile intentions. Until proven otherwise, therefore, it should be assumed that any such visitors are non-hostile and approachable. It is critical that humans avoid making anthropocentric assumptions regarding extraterrestrial motives, since it is likely that their ethical, moral, social and political concepts vary from those of many earth-based cultures. Recognizing the human tendency towards xenophobia, prejudice and fear of the unknown, we must evaluate extraterrestrial motives cautiously, and, to the extent possible, from an interplanetary perspective.

- The attainment of a healthy and appropriate collective self-esteem for humans is essential for an appropriate relationship to evolve between humans and any other extraterrestrial species. Individuals and organizations involved with interplanetary contact should avoid the common tendency to swing between viewing advanced technological beings as intrinsically superior or inferior. It is more sustainable to view such variations as simply differences which are the product of diverse evolutionary paths, and that on the level of conscious intelligence, all sentient beings are essentially equal. Here, equality does not require sameness.
- It should be realized that until the world achieves the level of maturity described above, that any direct contact and relationship which develops may be limited, preliminary, and by nature pioneering. Given recent CSETI successes in this regard, we can make the initial assessment that such contact is likely, and will progress as the world becomes increasingly a genuine global civilization.
- The knowledge of any contact and evolving relationship should be shared with all the peoples of the world to the fullest extent possible, and in a timely fashion. Secret or covert contact should be viewed as intrinsically dysfunctional and should be avoided to the fullest extent possible.
- A multi-disciplinary and multi-cultural approach to any contact, relationship, or exchange should be used. Communication itself may proceed verbally, electronically, "symbolically/archetypically" or even telepathically.
- A very broad view must be maintained in evaluating the manifestations of an advanced extraterrestrial civilization, since their technological development may be thousands to hundreds of thousands -- and conceivably millions - of years more advanced than earth's. The manifestations of such an advanced technology may appear magical to humans, even as a hologram, TV, or laser would appear magical to people of the 17th century. The tendency to pronounce such manifestations as "supernatural" or magical should be avoided.

Are we alone in the universe, and have other intelligent life forms found their way to our small part of the galaxy? The best available evidence suggest that, no, we are not alone, and yes, they have already found us. The real question at this point may be "what are we going to do about it?" We must come together to search for answers to this and even more difficult questions, for nothing less than the future of planet earth may hang in the balance. If we are wrong, and all of the existing evidence points to some other phenomenon, then the attempt to contact whatever that phenomenon is may prove extremely enlightening. But if we are correct in our assessment, and we are being visited by advanced extraterrestrial civilizations, then the risks of doing nothing are immense, and the benefits of acting wisely will change the world as we know it.

In either case, the time has come to act.

BRIEF SUMMARY  
OF  
CSETI RESEARCH RESULTS

**A. Mexico January 30, 1993:**

On January 30, 1993, the RMIT was activated and sent to the volcanic zone outside of Mexico City, Mexico. Just before 12:30 a.m., local time, on January 31, 1993, while engaging in CSETI protocols to vector extraterrestrial spacecraft into the site, the entire team was briefly engulfed in a beam of amber light, which originated in the northwest sky. No conventional source for this beam was found. Later, on February 1, 1993, the team was able to vector into the site a large triangular craft, measuring 300-800 feet in diameter (one to three football fields). This craft responded to the team's signals, circled the area, and descended with its leading edge fully illuminated in what appeared to be a landing attempt. This triangular craft was approximately 300 feet in elevation and under 5000 feet from the research site. It had a brilliant light at each corner of the triangle, and a red pulsating light in the center. It was accompanied by a small red-orange probe or scout craft. As the craft left the areas, it repeatedly returned signals from the team, and then dipped below a ridge and was not seen again that night. This contact lasted about ten minutes. On February 2, 1993, the same type craft returned, this time under 200 feet, and again signaled in an interactive manner with the team. During the last 24 hours the team was in Mexico, it encountered during daylight hours brilliant, shiny metallic discs which hovered or flew near the team members. Four such discs on four separate occasions were encountered by the team on February 3 and 4, 1993.

**B. England July 27, 1992:**

At approximately 12:20 a.m. on July 27, 1992, on an 1800 acre farm near Alton Barnes, Wiltshire, England, the CSETI RMIT was successful in vectoring into the site a large, brilliantly lit, disc-shaped, domed craft, measuring 80-150 feet in diameter. This craft was silent, and less than 400 yards away, and came to within 10-30 feet of the ground. It was, in fact, in the same wheat field in which the RMIT was located. This craft signaled repeatedly to the group of four researchers, and a small amber object at one point detached from the object and went up into the clouds. While at close proximity, this craft caused magnetic disturbances to the compass so that the needle rotated counterclockwise 360 degrees around the compass dial. This near-landing event concluded with the craft receding into the mist and out of visible range after 10-15 minutes of signaling with the team.

**C. Florida March 14, 1992:**

On March 14, 1992, at 8:24 p.m., CST, on a beach near Pensacola, Florida, over 40 people present for a CSETI research team training exercise, were able to vector into the area four silent, hovering craft, which signaled repeatedly to the group, and changed formation in response to the group's light signaling. This event was observed from six locations, and videotapes and photographic

evidence were obtained. These objects were under intelligent control and moved towards the group while exchanging light signaling with the team. This event lasted for 10-15 minutes.

#### D. Belgium February 5, 1992:

Having learned of a significant UFO wave in Belgium, the CSETI RMIT, consisting of four people, departed for Brussels on February 5, 1992. On the night of February 9-10, the team conducted research under unfavorable weather conditions near the town of Eupan, Belgium. At 12:30 a.m. on the 10th the team saw at low elevation four objects approximately 300 feet away, brightly lit, which vanished suddenly after about five minutes of observation. The team returned the next morning to the site, and no explanation for the objects was found.

On the night of February 10, 1992, the team proceeded to a high ridge near Henri-Chapelle, and at 12:45 a.m. on the 11th successfully vectored into the site a large triangular, silent craft which dipped below the low cloud cover to reveal a brilliantly lit apex of the triangle. The light on this part of the craft was about the size of a full moon. A few minutes later the team heard a low vibratory rumbling directly above them, which seemed to be turned on and off in rapid succession twice. This vibration was above the team in the clouds and was stationary.

STRATEGIES AND RATIONALE  
FOR  
CHANGING GOVERNMENT POLICY

It is recommended that current government policy on UFOs/ETI be changed to one of increasing disclosure, openness, and cooperation with civilian researchers. Failure to effect a review and policy change within the next 12-24 months may result in significant unfortunate outcomes insofar as it is likely that both civilian research initiatives (e.g., CSETI RMIT research projects) and imminent extraterrestrial events will overtake current policy.

A "window of opportunity" exists for the Administration to effect such a change. This unique window exists as the result of the confluence of two significant events.

1. The existing policy of secrecy exists, in part, because of justifiable concerns during the Cold War, which included the control of possible developments vis-a-vis extraterrestrial technology as well as more general psychological and sociological concerns. The ending of the Cold War provides for a plausible rationale for changing current policy at this time, and would provide the current Administration with an excellent explanation for the public so that past secrecy could be justified, thereby minimizing any embarrassment to past administrations, or to career government, military, and intelligence employees. Since some time has already elapsed since the end of the Cold War, this rationale is highly time sensitive.

2. Since the Clinton Administration is less than one year old, the President, the Secretary of Defense the Director of Central Intelligence, the new Chairman of the Joint Chiefs of Staff and other key government figures will have "plausible deniability" on this issue, so long as a policy change occurs in the first one to two years of the term. After that time, the Administration could be harmed by a late, uncontrolled disclosure since such an event would play to the public in one of two equally unacceptable ways: If the Administration claims ignorance on a subject this important, it will be accused of incompetence. And if the Administration admits to knowing about this subject, it will be subject to accusations of unwarranted secrecy, and possibly even "cover-up" by the media and public. At this point in time, the Administration would not be faulted for a one-to two-year delay in disclosure, and may even be viewed heroically by a majority of the American people, inasmuch as a majority of Americans already believe that UFOs are real and are most likely interplanetary craft.

We believe that this "window" provides for an historic opportunity to change current policy and enter a new era of openness on this important subject.

Beyond this, such a policy of openness, with the resulting disclosure of the existence of extraterrestrial life, could be a world unifying event which would serve the over-arching goal of world peace. Suddenly, the earth would indeed appear as one homeland inhabited by one people.

In advance of any change in policy, and subsequent disclosures, we would advise a concerted effort to confidentially brief select world leaders, leaders in society (including media, religious, business and academic leaders) and scientific leaders. CSETI, in cooperation with other researchers and organizations, has already begun this process, and welcomes cooperative initiatives from the current Administration.

Furthermore, it is our sincere desire that this matter be handled in such a way that neither the government of the United States nor world society in general will be harmed. We would like to extend our offer to help in this process to the fullest extent possible, and recommend that a dialogue on this subject proceed in a thoughtful yet somewhat urgent manner.

We also recommend that the international community be encouraged to support and expand a worldwide diplomatic and research initiative to establish increasingly open contact between earth civilization and extraterrestrial civilizations. CSETI has already established such an initiative and is willing to work openly with the international community to advance this process.

- 1990 \*
- Dr. Steven M. Greer of Asheville, North Carolina, establishes CSETI, calling it a scientific and visionary project of 60 to 100 years to make assessments about ETI and, ultimately, to establish peaceful interplanetary relationships.
  - \* Late in the year, small Working Groups are established during a University of North Carolina conference. A temporary Executive Committee is formed.
- 1991 \*
- Working Group Protocols are established in April for real-time research and diplomatic projects.
  - \* A March 15 CE-5 occurs in Dandridge, Tenn., near the site of a CSETI research operation. The incident occurred during multiple sightings in that area, including one UFO appearance which the local sheriff video-taped. These UFO activities culminated in May, with the reported landing of one UFO, which left a circular imprint approximately 28-feet in diameter.
  - \* The first outstate CSETI Working Group is formed in Denver. Subsequent groups are established in Phoenix, central and southern Florida, Ft. Collins, Co., Los Angeles, Belgium, and late in '92, Germany.
- 1992 \*
- February 9. In Belgium, a CE-5 takes place with a CSETI team and Belgium authorities and scientists present during a "wave" of UFO activity. More than 3,500 official UFO sightings have taken place in this European capital since November 1989.
  - \* March 14. A dramatic CE-5 takes place in Gulf Breeze, Fla., initiated by CSETI. Three UFOs break into a triangulated pattern, mimicking the light formation projected into the night sky by the local Working Group. One UFO responds in kind to repeated light flashes. The event is witnessed from seven different locations by more than 50 people and captured on video, audio, and photographic equipment.
  - \* May. Doctor Greer addresses the International Association of New Science (IANS), co-founded by former Apollo astronaut-scientist Brian O'Leary, in Denver.
  - \* June 28. Laramie, Wyo., is the site of another CE-5, during which two UFOs are vectored to within two to four miles of a CSETI Working Group.

- \* July 20-30. Southern England, Alton Barnes region. A CSETI RMIT team joins Colin Andrews Crop Circle Phenomena Research (CPR) International to study whether a link exists between UFO activity and Crop Circle creations. One of the most significant events in the history of UFOlogy transpires.

Using the Contact Trilogy, the two teams visualize and illuminate in the sky an equilateral triangle with circles at each point. The next day such a formation is found within direct view of the CSETI-CPR research site. Throughout the 10-day research period, many anomalous lights are seen and an unusual CE-5 is multiply witnessed by Greer and others on July 27 in the area. On that night, a structured spacecraft made a near-landing only 400-yards from the research team.

- \* In the fall, CSETI formally organizes its Executive Council and opens its main office headquarters in Asheville, North Carolina. Dr. Greer semi-retires from his hospital position to devote more time to CSETI's operations and ongoing research.

- \* January. CSETI Executive Council meets and announces the publication of its quarterly journal -- JETI -- Journal of Extraterrestrial Intelligence.
  - \* February. CSETI begins its official media campaign and public education programs to begin informational briefings about CSETI activities and ETI research.
  - \* March 6-10. CSETI conducts its first extensive Working Group seminar in Arizona.

Dr. Steven M. Greer is Chairman of the Department of Emergency Medicine at a hospital in North Carolina. He received his M.D. degree from East Tennessee State University (ETSU) College of Medicine and is a member of Alpha Omega Alpha (AOA), the nation's most prestigious medical honor society. He was born in Charlotte, N.C., in 1955.

Dr. Greer has extensive experience in health education, stress management training, and emergency and family medicine. A strong believer in holistic medicine that treats the body, mind and spirit, Greer promotes the complimentary nature of many approaches to health and healing through education and patient care. To facilitate those goals, in 1988 he established the Shambala Institute, a non-profit health care and educational organization in Asheville.

Greer has lived, worked and studied in the Caribbean, Europe and Israel. He was trained as a Transcendental Meditation teacher in 1975, and served as the Director of the International Meditation Society in Bahamas in 1976. He is active in the Baha'i Faith and served at its world headquarters in Haifa, Israel 1978-80.

Doctor Richard F. Haines  
Biography

Richard F. Haines was born and raised in Seattle, Washington, and attended the University of Washington College of Engineering and Pacific Lutheran College (Tacoma) where he received a B.A. degree in 1960. He was awarded an M.A. and Ph.D. from Michigan State University (East Lansing) in 1962 and 1964, respectively, in the field of Experimental Psychology.

Haines worked at NASA-Ames from 1967 to 1986 as a research scientist in numerous astronautical programs, including Gemini, Apollo, Skylab, and Space Station, plus many aeronautical programs where he was Manager of the Joint FAA/NASA Head-up Display Program and landing simulation research projects. From 1986-1988, he was appointed Chief of the Space Human Factors Office at NASA-Ames, directing research and development efforts of the AX-5 "hard" EVA space suit, habitability design research for Space Station Freedom, and spacecraft window design.

He retired from government service in 1988 and taught at San Jose State University as an Associate Professor of Psychology while working part time as a scientist in the Research Institute for Advanced Computer Science. From 1990 to 1991 he has provided consulting services to NASA in various laboratory activities related to supersonic wind tunnel automation redesign and Space Station Freedom-to-ground bandwidth image transmission reduction.

His interest in UFO phenomena spans more than 20-years with special interests in pilot sightings, photographic evidence analysis, and data on Close Encounters of the Fourth Kind, noting that "these areas contain the type of data that will bring us to a successful discovery of the core nature of the phenomena."

Haines recently founded and co-directs the "Joint American-Soviet Aerial Anomaly Federation" (JASAAF). He is the author of more than 55 scientific journal articles and the editor of UFO Phenomena and the Behavioral Sciences (The Scarecrow Press, 1979). He has written Observing UFOs (Nelson-Hall Publishers, 1980); Melbourne Episode-Case Study of a Missing Pilot (LDA Press, 1987); and Advanced Aerial Devices Reported During the Korean War (LDA Press, 1990).

He serves on the CSETI Executive Council as a scientific coordinator for the Department of Research. His complete professional biography can be found in Who's Who in America, Who's Who in California and other similar publications.

Doctor Joseph Burkes  
Biography

Dr. Joseph Burkes is a Board Certified Internist living in Southern California. He is a partner in a medical group serving a large Health Maintenance Organization and works in the emergency room. Burkes received his M.D. degree from Tufts University School of Medicine in Boston Massachusetts. He was born in New York City in 1949.

Dr. Burkes has been a lifelong activist in the peace and social justice movements. During the Vietnam War he organized students in antiwar protest activities and in 1979 he co-founded the Los Angeles Committee on Occupational Safety and Health, a coalition of medical and legal professionals assisting the labor movement to make the American work place safer.

During the 1980s, as the nuclear arms race intensified, he and thousands of other medical doctors, joined Physicians for Social Responsibility (PSR), an organization established to educate the public and government leaders about the medical consequences of nuclear war. Serving in PSR's Los Angeles chapter, he co-produced a weekly radio talk show titled, "Prescription for Survival," heard on listener-supported KPFK-FM.

As head of PSR's speakers training, he assisted his colleagues in becoming effective public speakers in PSR's campaign against the arms race. He was appointed the Pacific Regional Director for the organization and also served on PSR's National Board of Directors.

During his years in the physicians' peace movement he engaged in citizens' diplomacy and travelled to the USSR four times. There he met with Soviet doctors who were engaged in a similar educational effort under the auspices of the organization International Physicians for the Prevention of Nuclear War, which was awarded the Nobel Prize for its service to promote world peace.

In May of 1992 he met Dr. Steven Greer, a fellow emergency room physician. Dr. Burkes was named the Los Angeles Working Group Coordinator for The CE-5 Initiative and serves as the CSETI liaison to Latin America. As a member of the CSETI Executive Council in the Department of Education, he is responsible for the National Speakers Bureau. He is of Russian-Jewish descent and speaks both Spanish and Russian.



The scope of what we are attempting is immense. Financial support is essential to the success of our projects. Membership or a contribution of any amount will help.

The "Best Available Evidence" project is currently seeking the most recent verifiable evidence of ETI encounters on the planet. This information will be used in the presentations to world leaders. Encounters verifiable by multiple witnesses, multiple video or still photography images, physical evidence, etc. are needed.

Dear President Clinton,

Thank you for your letter of August 3, 1995, written by Mr. James Dorskind on your behalf, and for your consideration of our request to meet with relevant members of the Administration on the UFO/ETI subject.

We feel that the time has come to permit a number of our witnesses to speak openly about their involvement with U.S. government military and intelligence operations dealing with extraterrestrial spacecraft and related matters. Our witness pool continues to grow, and we would like to meet with relevant members of the Administration as soon as possible to discuss protection for these witnesses.

It is our opinion that it is in the best interests of the Administration, and of the American people, to have these witnesses disclose their information in the context of a cooperative effort with the government. At a minimum, these heroic witnesses deserve protection from prosecution for violating national security oaths, and need specific protection from all civil and military prosecution. A few of them need physical protection, since some of them sense that they and/or their families may be in real physical danger.

I am enclosing a briefing on the national security implications of the UFO/ETI subject, which is being distributed to certain figures in the US and abroad who are connected to national and international security concerns. It is intended to be a brief summary of national security implications for the President, the National Security Advisor and other relevant members of the US national security apparatus.

Please let us know how we may proceed with a meeting with members of your Administration on this important and pressing issue.

## National Security Implications of the UFO/ETI Subject: A Brief Summary

National Security Implications of the UFO/ETI subject are profound and far-reaching, albeit currently largely unrecognized.

These implications may be considered in separate but related aspects: those intrinsic to ET activity and those arising from current covert management of the issue.

### Historical Background:

Early National Security considerations dealt with concern over public panic arising from the detection of near earth and earth-landed extraterrestrial spacecraft (ETS) and from the technological implications of advanced Extraterrestrial material as it may impact the arms race and cold war. Additional concerns were related to the impact on religious belief systems, the political order and economic systems.

Importantly, once actual ETS were retrieved in 1947, thereby allowing Extraterrestrial hardware to be studied and back-engineered for possible human military applications, the need for complete secrecy regarding the matter was deemed paramount by authorities at that time. Given the tensions of the early atomic era and the mounting 'cold war' with the USSR, it is understandable that the introduction of Extraterrestrial technology was thought to be destabilizing to an already dangerous situation. Moreover, given the history of technological secrets related to atomic and hydrogen weapons being stolen by agents of the USSR, there was understandable concern that any technological breakthrough related to Extraterrestrial technology might find its way into Soviet hands. If such an event enabled the USSR to produce actual military applications before the US, obviously this would have placed the US military capability in a potentially catastrophic disadvantage.

Since the 1970's, we have reason to believe that a degree of cooperation on this matter has evolved with the USSR and the US and perhaps other nations. Certainly the end of the cold war has largely removed earlier concerns vis a vis technological breakthroughs and the fear of Soviet aggression.

Moreover, the psychological reasons for secrecy related to public panic are not valid today. At least 57% of the population accept that UFOs are real and are of Extraterrestrial origin. And 30-40 years of space exploration by human society has prepared the population for the possible existence of other Extraterrestrial civilizations capable of space travel. In short, the previous concerns motivating secrecy are not relevant today.

Intrinsically, there is no reason to believe that the Extraterrestrial presence poses a threat to the national or world security. If hostility and aggression were related to their purpose here, it is likely that events congruent with hostility would have transpired long before now. It is our assessment that the Extraterrestrials are not hostile, but are very concerned with human capability related to warfare and the militarization of space. Activity by Extraterrestrial assets related to

the neutralization of ICBM facilities and to containing military oriented space exploration should be understood in light of their concern over a known history of human aggression which has been coupled with the advent of weapons of mass destruction and space exploration. Indeed, given the past history of human military assets focusing on and pursuing Extraterrestrial Spacecraft, we believe the Extraterrestrials have responded with remarkable restraint.

Ironically, the threat to national security exists not with the Extraterrestrial presence, but the current covert management of the subject. In the absence of Extraterrestrial hostility over 50 years, current secrecy cannot be justified on the basis of fear of Extraterrestrial aggression. A disclosure related to the Extraterrestrial presence, if calmly and rationally presented, will not cause public panic in the US or elsewhere. 1995 is not 1945, and world society has evolved to the point where this information can be assimilated in a positive fashion.

In contrast, the covert and apparently extra-constitutional management of this matter is a real threat to national and world security, and undermines constitutional freedom and democracy. Unless it is terminated, this covert management will greatly harm US national security and the chances of a lasting world peace.

It is our assessment that the current covert management of this issue involves the following elements which are a direct, immediate and ongoing threat to the national security:

1. The continued denial of the Extraterrestrial presence creates a situation where a sudden, undeniable, public Extraterrestrial event could induce panic, since proactive disclosure efforts which could ameliorate public fears are non-existent. It is likely that such a public Extraterrestrial event will transpire within the next 2-10 years or sooner. Therefore secrecy and denial are a real threat to national and world security.
2. The current covert management of this issue appears to be operating independently and outside of the constitutional chain of command. The group controlling these operations, which involve reconnaissance, Extraterrestrial technology back-engineering, and space - based targeting of ETS (among others) is non-responsive to congressional or Executive branch oversight and control. This constitutes a real and grave threat to the national security and to constitutional democracy and freedom.
3. We have credible, first hand sources who insist that extraterrestrial spacecraft have been targeted by human covert space weapons and on at least two occasions have been destroyed. If true, the risks to world peace and security are real and imminent, and the continuation of these covert activities constitute the gravest dangers to national and world security. Hostile actions taken by human covert assets against Extraterrestrial assets constitute a grave and immediate threat to the national security. A relatively small, covert entity, acting without consultation with the United Nations, the Congress, the President of the United States or the public is engaging in actions on behalf of all humans which endanger the earth and world peace. Unless controlled, these actions could precipitate interplanetary conflict and a disaster for the world generally and the United States specifically. This covert management must be terminated and control of this issue returned to constitutional authority and to the public domain.

4. The concentration of the technological advances related to the back-engineering of Extraterrestrial technology into the hands of a small covert operation constitutes a grave and immediate threat to the national security, to world security and to the future of the earth. These Extraterrestrial technologies, which have been the object of covert research and development for over 45 years, are potentially of great benefit to humanity if used wisely for peaceful purposes, but are of immense danger when concentrated into a small covert operation which is unresponsive to the public or the legal and constitutional chain of command. The threat this poses to the US and world security is great, and the longer this situation continues, the greater the concentration of advanced technological power in the hands of a relative few. The secret control of such powerful technologies is inherently a threat to freedom, democracy and to our nation and the world. Its utilization for covert agendas outside constitutional control represents a grave danger to our country and must be restrained and reversed.

5. Importantly, secrecy and covert operatives per se constitute a real threat to the national security, since national security in a constitutional democracy can only be legitimately related to freedom and democratic government. Only in very rare and well-justified circumstances can extreme secrecy and covert operations exist, since by nature freedom and democracy cannot co-exist with unrestrained secrecy and secret power. The profound implications of the detection of Extraterrestrial civilizations cannot be allowed to be the exclusive domain of covert operations which are unrelated to public discourse and consultation. To do so is to undermine the US Constitution, democracy and freedom, and this constitutes a real and grave threat to the national security.

6. Finally, exclusive covert control of this matter has resulted and continues to result in the loss of opportunity for the world to come to terms with the Extraterrestrial presence in a peaceful and mutually beneficial fashion. This means that the people of the world, the United Nations and other international and national institutions are deprived of the opportunity to deal rationally with this issue. National and world security are therefore negatively impacted by the loss of opportunities in the following areas:

> The Environment, which is seriously at risk for large scale collapse over the next 100 years, would be profoundly improved if extraterrestrial technologies could be peacefully deployed. So-called zero point or free energy systems, which are non-polluting, would permit a sustainable technological civilization to exist on earth and would transform the earth environmentally and economically. Establishing peaceful and mutually beneficial relations with extraterrestrial civilizations would eventually permit us to understand and apply such technologies.

> World unity and peace will be enhanced by the global realization that we are not alone in the universe. The acknowledgement of this fact will enhance the awareness that we are really one people living on the shared homeland of earth, and many of the conflicts currently afflicting the earth will be seen in a new perspective. This can be achieved without either deifying or demonizing the extraterrestrial presence, but rather placing it in a fair, scientific and neutral light. Eventually, world peace and a significant enhancement in the current geopolitical situation may result from the disclosure that we are not alone. An international infrastructure, and institutions capable of dealing peacefully with relations with extraterrestrial civilizations would, of necessity,

evolve, and this in turn would strengthen world unity and cooperation.

>World culture, ideas, science and many other diverse areas may benefit through the development of peaceful relations with other worlds. While this process may take decades, if not centuries, its delay only puts off the time when the people of the earth will be united not only globally, but with other planetary civilizations as well.

In summary, it is imperative to the national security that the president and Congress undertake measures to terminate the secret, covert management of the UFO/ETI subject. Failure to place this matter in open, public discourse and control constitutes the gravest failure of democracy and government in the history of the world. That we do this is the test of our faith in democracy and our faith in the people. As the 21st century approaches, we must roll up the cancerous excesses of secrecy which are the legacy of the cold war and unfurl a new era wherein democracy is reaffirmed and a lasting world peace is given a chance.
